Market West is a member organisation for fresh produce wholesalers and industry associates at the Perth Markets in Canning Vale.

Mission

To actively represent and service the interests of primary wholesalers in the Perth fruit and vegetable market, with a focus on industry growth and advancement.

Vision

To secure a thriving and sustainable Western Australian fresh produce industry for future generations.

Role of Market West

Market West's purpose is to:

- ◆ To unite and preserve unity amongst wholesalers of the fresh produce industry in Western Australia
- ◆ To encourage communication and co-operation with other associations and industry groups engaged in the fresh produce industry
- ◆ To promote the benefits of fresh produce to retailers and consumers
- ◆ To protect and promote the interests of all members in matters affecting their business and trading operations in Western Australia
- ◆ To make representation to any government organisation or industry authority on behalf of members in respect to any issue or regulation which may affect the interest of members
- ◆ To provide services to its members

TYPES OF MEMBERSHIPS:

Ordinary Membership

Market West membership is available to any wholesale fruit and / or vegetable merchant, agent or distributor carrying on a business in the area defined as the Central Trading Area within the Perth Markets situated in Canning Vale, Western Australia.

Associate Membership

Market West associate membership is available to any wholesale fruit and / or vegetable merchant, agent or distributor carrying on a business outside the area defined as the Central Trading Area, but within Market City situated in, Canning Vale, Western Australia.

Affiliate Membership

Affiliate membership is available to any person, firm, company or corporation involved directly or indirectly with the Fruit and Vegetable Industries including, but not limited to, Crate exchanges, Transporters, Growers, Retailers and consultants to the industries.

SERVICES

Representation and Communication

Market West represents its Members locally and nationally as part of Fresh Markets Australia, with State and Federal Governments and other associations and industry groups, acting in the best interests of Members.

Market West Credit Service

Market West Credit Service acts on behalf of the member wholesalers in the Central Trading Area as a consolidated billing service. We provide a 7 day credit facility on behalf of our Members, which allows buyers to trade with Members in the central trading area and receive one weekly consolidated account, providing a secure weekly cash flow from buyers.

LPG Service

An on-site LPG forklift refueling facility provides ready access to LPG for registered customers in compliant forklifts. Approved users can fill Forklifts at their own convenience with the use of a pin coded fob/gas key. Each month, users will be invoiced for their usage from billing software, payable within 14 days. This means there is no need to have LPG exchange cylinders delivered and stored on site (increased safety).

Events

Market West provides social and networking opportunities for Members through our annual events such as the Perth Markets Ball incorporating the Fresh Produce Retailer of the Year awards and the Annual Charity Cherry Auction.

Telstra Mobile Phone Service

Market West has negotiated a, national low cost Telstra mobile phone account that provides Members and associated groups with a very competitive mobile phone service, invoiced monthly.

Boardroom Facility

Facilities are available for Members to hold their own meetings or training sessions in a well appointed Boardroom, which can also be configured in classroom style (30 max).

Price Reporting

Daily, Monthly and Yearly summary reports are available for the Perth wholesale markets. Prices reported are submitted by the key wholesalers of each product type in the market. Information is collected from summary sales data.

Fresh Test

Fresh Test facilitates chemical and microbial testing of fresh produce for wholesalers and growers. A service which meets Australian standards for members quality assurance programs facilitated and supported by the Chamber with a competitive cost to wholesalers

Fresh Specs

Fresh Specs is a product specification standard which assists with meeting quality assurance standards.
